## CONDITIONS & PROCEDURES

- All persons who want to qualify for production or to complete training workshops will be required to abide by the station's *Operating Rules & Procedures*, a take home copy of which will be provided to serious inquirers. The *Operating Rules & Procedures* describe in detail the responsibilities and liabilities of the participating individual(s) and of CTSB-TV.
- Also included are descriptions of the three "PEG" Channels (Public, Education, Government), training, the proper use of equipment and facilities, access Channel times, underwriting of programs, production requirements, violations of rules and procedures, among other important subjects. A sample copy may be examined at the station office.
- Producers will have the assistance of a CTSB technician whenever producing a program. Schedules for such programs will be coordinated with, and approved by the Station Manager in order to assure that Producers are able to receive the necessary technical assistance to complete their shows.
- Membership fees are non-refundable upon termination or revocation. Fees for all members are payable at the beginning of the "membership year," currently defined as September 1 through August 31.
- Each member will be expected to sign an acceptance form, stating that he/she understands the *Operating Rules and Procedures*, and any other pertinent documentation relating to membership in the Corporation. Members are expected to abide by all bylaws, policies, rules and procedures set forth by the membership, Board of Directors, and Staff.
- Members joining after March 30<sup>th</sup> of the membership year pay half the appropriate membership fee, and the full fee is due again on September 1 of the following year. Members joining between August 1-August 31 of a given year are afforded membership for the following membership year.

### MEMBERSHIP CLASSES

**Class I** A Member must reside, work in, or be retired from employment of one of the five towns and will have full Membership rights, including voting at Membership meetings, and can be nominated for a seat on the Board of Directors.

**Class II** consists of students and educators who participate in training workshops or production projects. Members are not required to pay Membership dues but have other rights of Membership.

**Class III** Members do not have the right to vote but when qualified have access to the studio and equipment, in accordance with the Operating Rules.

### Family Memberships

Families that are accepted for Full (Voting) Family Membership must contain at least one adult who qualifies under the conditions for Full Voting Membership. A second adult listed for the family will be named an Associate Member and up to two under-18 Associate Members are allowed.
